 <b>1.Reinstatement Application</b> : Please be sure that all information is completed on the application.
 2. Fee for applicant due to lapse of license: The reinstatement fee for a Dental Assistant II Registration is \$125 and must be paid with a certified check, cashier's check or money order, made payable to the Treasurer of Virginia. The fee can be used for one year from date of receipt. Pursuant to 18VAC60-30-30(F), all fees are non-refundable. Your application will not be reviewed until you have submitted payment.
Fee for applicant due to previously revoked or indefinitely suspended license: The reinstatement fee for a previously revoked Dental Assistant II registration is \$300 and the reinstatement fee for a previously indefinitely suspended Dental Assistant II registration is \$250.
 <b>5.Form C:</b> Original licensure verification from any jurisdiction in which you currently hold or have ever held a license/registration/certification to practice as a dental assistant or as another health care professional <u>and</u> certification of authorization to perform expanded duties as a dental assistant. Copies of permits are not accepted. Verification cannot be older than 6 months from date prepared.
 <b>6.</b> Evidence of a <u>current</u> credential as a <b>Certified Dental Assistant</b> (CDA) conferred by the Dental National Board (DANB) or another certification from a credentialing organization recognized by the American Dental Association and acceptable to the board.
 <b>7.Evidence of Continuing Clinical Competence:</b> The applicant must include documentation in the application sufficient to demonstrate continuing clinical competence in the duties for which the applicant is requesting reinstatement of, which may include documentation of active practice in another state or in federal service, or a refresher course offered by an educational program accredited by the Commission on Dental Accreditation of the American Dental Association.
 <b>8.Name Change:</b> Documentation must be provided to show each name change(s) if your name has ever been changed from the most recent time you held an active license in Virginia or were licensed in other jurisdictions or other than what is listed on your application. Photocopies of marriage licenses or court orders are accepted.

9.Please be aware that your signed and notarized application affidavit authorizes the release of confidential information, affirms that your application is complete and correct, and attests that you have read and understand and will remain current with the laws and regulations governing the practice of dentistry and dental assisting in Virginia.

### **PLEASE NOTE:**

- If your Virginia Registration is not reinstated within six months of the Board's receipt of the application, certain portions of the application may need to be resubmitted before your application can be reviewed.

- To receive notice that your application has been delivered to the Board, it is suggested that the complete packet be mailed by "Certified Mail-Return Receipt Requested" or with "Delivery Confirmation".

- Documents submitted with an application are the property of the board and cannot be returned.
