As the amount of just compensation for my home site has not been agreed upon, I am requesting this provisional payment with the understanding that if there is an increase in the acquisition price for my home site (land, dwelling, improvements, and damages to the home site, if any), whether determined by the courts or subsequent agreement with VDOT, my replacement housing payment will be recomputed. The computation will compare the increased acquisition price of my home site to the lesser of (a) the available comparable selected by VDOT <u>or</u> (b) the actual price paid by me for replacement housing. If the home site represents only a portion of the total property acquired by VDOT, my replacement housing payment will be recomputed based on the same portion of the value used in determining my original replacement housing payment.

If an increase in acquisition price causes the recomputed replacement housing payment to be less than the replacement housing payment requested, I will refund the difference to VDOT from the court award or agreed settlement. I understand that the difference in the replacement housing payment will be deducted from the court award or agreed settlement before final payment is made. However, I will not be required to refund more than the replacement housing payment received.
