Professional Corporation Information Sheet

All applicants must be incorporated in the Commonwealth of Virginia, or if a foreign professional corporation, shall have obtained a certificate of authority to conduct business in Virginia from the State Corporation Commission in accordance with § 13.1-544.2 of the *Code of Virginia*. Under no circumstances is a corporation authorized to render professional services in Virginia until it has obtained a certificate of incorporation or authority from the Virginia State Corporation Commission <u>and</u> a certificate of authority from the Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects. The certificate of authority issued by the Virginia Board permits a corporation to practice only the professions shown on the certificate of authority.

If professional services are offered or rendered in a branch office, a separate *Professional Corporation Branch Office Registration Application* must be completed for <u>each</u> branch office. At least one currently licensed or certified responsible person (as defined by regulation 18 VAC 10-20-10) in each profession offered or practiced in each branch office must be resident at the branch to provide effective supervision and control of the final professional product.

Regulation 18 VAC 10-20-530.C of the *Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects Regulations* requires the following statements in the professional corporation's articles of incorporation and bylaws:

- Cumulative voting is prohibited.
- → At least two-thirds of the capital stock must be held by persons duly licensed to render the services of architect, professional engineer, land surveyor, surveyor photogrammetrist, landscape architect, or to individuals legally authorized to use the title of certified interior designer. The remainder of the stock may be issued only to and held by individuals who are employees of the corporation. For purposes of stock ownership, an employee of a corporation is defined as a person regularly employed by the corporation who devotes 60% or more of his gainfully employed time to that of the corporation.
- Non-licensed or non-certified individuals will not have a voice or standing in any matter affecting the practice of the corporation requiring professional expertise or in any matter considered professional practice, or both.

The corporation may elect to its Board of directors not more than one-third of its members who are employees of the corporation and are <u>not</u> authorized to render professional services. At least two-thirds of the Board of directors shall be licensed to render the services of architect, professional engineer, land surveyor (including surveyor photogrammetrist), landscape architect, or duly certified to use the title of certified interior designer, or any combination thereof. At least one director currently licensed or certified in each profession offered or practiced shall be resident at the business to provide effective supervision and control of the final professional product.

Joint ownership of corporate stock is prohibited. Ownership of stock by non-licensed or non-certified employees shall not entitle those employees to vote in any matter affecting the practice of professions for which the professional corporation is registered.

<u>Foreign professional corporation</u> bylaws must state that the corporation's activities in Virginia shall be limited to rendering the services of architect, professional engineer, land surveyor (including surveyor photogrammetrist), landscape architect and certified interior designer, or any combination thereof. Foreign corporations are not required to comply with the provisions of 18 VAC 10-20-530.C.2 of the Board regulations.

The chairperson or vice-chairman of the Board of directors, the president or any other of its officers authorized to act on behalf of the professional corporation may execute documents in the name of the corporation. Any amendments to the corporation's charter, articles of incorporation, or bylaws; changes in directors or shareholders; and changes in the name, address, place of business in Virginia, or responsible person(s) of the profession(s) practiced or offered at each place of business shall be reported in accordance with Board regulation 18 VAC 10-20-560.

Similarly, for those corporations using the title of certified interior designers and providing the services of architects, professional engineers, land surveyors, surveyor photogrammetrists, landscape architects or any combination thereof, at least two-thirds of the capital stock of the corporation shall be held by individuals who are duly licensed. The remainder of the stock may be issued only to and held by individuals who are employees of the corporation as defined in 18 VAC 10-20-510 of the Board regulations.
