

GENERAL INFORMATION AND INSTRUCTIONS

FOR LATE RENEWAL AS A

SOCIAL WORKER (LSW) OR CLINICAL SOCIAL WORKER (LCSW)

A social worker or clinical social worker whose license has expired may renew that license <u>within one year</u> after its expiration date by:

- 1. Providing evidence of having met all applicable continuing education requirements; and
- 2. Paying the penalty for late renewal and the renewal fee as prescribed in 18VAC140-20-30

Instructions:

Submit the enclosed renewal request and supporting documentation in **one** package to the address indicated above. Please review this checklist to make certain that **all** the required documents are submitted.

Fee: the following fee must be paid:

- Licensed Social Workers (LSW) will be required to submit \$65.00 fee, plus a \$20.00 late fee which must be paid by check or money order made payable to the "Treasurer of Virginia". This fee is non-refundable.
- Licensed Clinical Social Workers (LCSW) will be required to submit \$90.00 fee, plus a \$30.00 late fee which must be paid by check or money order made payable to the "Treasurer of Virginia". This fee is non-refundable.

Continuing Education (CE) Certificates:


- Licensed Social Workers (LSW) are required to complete CE for a minimum of 15 hours including two (2) hours that pertain to ethics or the standards of practice for the behavioral health professions or to laws governing the practice of social work in Virginia.
- Licensed Clinical Social Workers (LCSW) are required to complete CE for a minimum of 30 hours of including two (2) hours that pertain to ethics or the standards of practice for the behavioral health professions or to laws governing the practice of social work in Virginia.
