Virginia residents must complete a *Criminal History Record Name Search Request* form (Form S.P. 167) in the presence of a notary public and mail it to the Virginia State Police, Central Criminal Records Exchange, Post Office Box 85076, Richmond, Virginia, 23261-5076.

Applicants with criminal convictions and/or regulatory board disciplinary actions may be required to attend a hearing before the Real Estate Appraiser Board. This hearing process may take an additional two to three months.
