All applicants must <u>meet the current eligibility requirements at the time the completed application package is received at the Board office</u>. Completed application packages must include all required documentation, references, verifications, and fees. All forms must be legible. After applicants pass the Fundamentals of Engineering exam, they may apply to the Board for the Engineer-in-Training designation.

APPLICANTS APPLYING UNDER THE PROVISIONS OF 18VAC10-20-190.A

Board regulation 18VAC10-20-190.A states that applicants who are enrolled in an ABET accredited undergraduate curriculum and have 12 months or less before completion of their degree are eligible to take the Fundamentals of Engineering Examination. Applicants that are enrolled in an ABET accredited master's or doctorate curriculum, or are enrolled in a graduate curriculum that is ABET accredited at the undergraduate level at the institution at which the graduate degree is being sought and have six months or less remaining before completion of graduate degree requirements, are also eligible to take the Fundamentals of Engineering Exam. Individuals applying under this provision must submit the following documentation after taking the exam, prior to graduation:

- > a completed *Engineer-in-Training Designation Application* and fee;
- > a *<u>Certificate of Good Standing</u>* from the dean of the engineering school in which the applicant is enrolled

ALL OTHER APPLICANTS

Individuals applying under the provisions of 18VAC10-20-190.B, .C, .D, or .E must submit the following documentation:

- > a completed *Engineer-in-Training Designation Application* and fee;
- a completed <u>Engineer-in-Training Reference Form</u> (less than one year old) completed by a licensed professional engineer, the dean of the engineering school, a department professor in the school attended by the applicant or an immediate supervisor (all references must have known the applicant for at least one year) and been associated with the applicant within the last 5 years;
- > a completed *Degree Verification Form* or official school transcripts;
- official school transcripts if applying under 18VAC10-20-190.E and a <u>Course Requirements for Engineering Technology</u> <u>Program Form</u>.
- completed <u>Experience Verification Form(s)</u> if you are applying under 18VAC10-20-190.D or 18VAC10-20-190.E.

EDUCATION

All applications are evaluated based on the undergraduate degree held by the applicant (*unless the applicant holds a graduate degree which is ABET accredited at the graduate level*). Applicants should forward the <u>Degree Verification Form</u> to the college or university from which any degree(s) were obtained (unless official school transcripts are required). In order to receive the EIT Designation, candidates applying under 18VAC10-20-190.A must submit a completed <u>Degree Verification Form</u> or an official transcript.

Individuals holding a master's degree from a college or university that is ABET accredited at the undergraduate or graduate level should also submit a <u>Degree Verification Form</u>. Applicants who have earned a degree from an institution outside the United States must have their degree authenticated and evaluated by an education evaluation service if credit is sought for this education. However, if the applicant also holds an equivalent or higher-level engineering degree from a United States institution where the program has been accredited by ABET, no evaluation is required; however, the degree must be verified using the <u>Degree Verification Form</u> or official transcript. The Board reserves the right to reject an evaluation submitted by an applicant. AN EVALUATION DOES NOT CONSTITUTE ABET ACCREDITATION.

EXPERIENCE

Applicants applying under 18VAC10-20-190.D and 18VAC10-20-190.E must verify all experience on *Experience Verification Form(s)*. Any experience verified on forms other than those provided by the Department of Professional and Occupational Regulation will <u>not</u> be considered. Resumes and attachments are <u>not</u> acceptable. Please refer to 18VAC10-20-160 and 18VAC10-20-240 of the Board Regulations for definitions of qualifying and nonqualifying experience. No credit is allowed for non-verified experience.

TOEFLIBT (formerly known as TOEFL)

Applicants for licensure must be able to speak and write English to the satisfaction of the Board. Applicants from a non-English speaking country or a country where the primary language is not English, who have not graduated from a college or university in which English is the language of instruction, shall submit to the Board a TOEFLIBT (Test of English as a Foreign Language) score report that reflects a score acceptable to the Board. Score reports shall not be more than two years old at the time of application.
